# 5. Study plan revision

The Study Board secretariat has received a mail regarding the new reform for master programs. Basically, it means that the department should consider cutting down 25% of the ECTS of some of our master programs (from 120 ECTS to 75 ECTS). To this topic we have invited head of department Hans Jørgen Andersen (HJA) to explain what this means, and which study programs that could be in focus.

We have received some background material to support this topic. See attachment on Moodle.

HJA explains that it is a political decision, and we cannot really debate whether it is clever or not. We could in principle say "we will do nothing", but then it is almost certain that the dean or head of university will make the decision for us.

Hence, the thought from HJA is to change the Master's in Medialogy to 75 ECTS (25%) in both Aalborg and Copenhagen. Our other Master's programs (SSD, and LiD) are not realistic to pick for this. Mainly because the other programs will suffer from having less international students that will not come to DK to study for such a short period, and it will also be difficult to support qualified research groups when they are based on such scaled down educations. SMC is already scheduled for closure, so it is not relevant to consider that, either. SMC is still targeted to become a specialization under Medialogy.

Is it possible to move the students into "erhvervskandidatforløb" like the students from A&D? HJA: It is, but the students will have to find employment during the study, as it is not funded by SU. It will demand a lot from the department to secure employment to all students.

Regarding economy HJA explained it will be less income for the department if we choose the 75 ECTS program, but we will also spend less money on running the program.

CBM has contacted the legal office regarding length of the master thesis in the 75 ECTS program. The thesis will probably be cut down to 15 ECTS out of the 75. The whole education will have to start earlier than the rest. Finally, the study plan will have to be approved within November 1, 2024.

DM: Master's programs in Britain are for 1 year. Traditionally programs are more project based with a high research aspect.

We had a debate about pros and cons.

What do the students think of it?

LGR: Prefer depth than broad. Medialogy is already broad.



#### Conclusion:

In view of the options, and in view of the fact that it is somewhat a "pest or cholera" situation, the Study Board of Media Technology supports the idea of proposing that the department can cut the Master's in Medialogy down to 75 ECTS, but it will have major consequences. Some of these we really do not know yet. It will push us to revise both our Bachelor and Master's study plans for Medialogy with a short notice. The study board does not believe it will make sense to alter the Master's study plan so much, without also making major changes to the Bachelor study plan.

Some of the questions and observations from the Study Board that the department may bring further up the command line:

- The Study Board of Media Technology (MSN) is concerned that reducing the Master's in Medialogy to 75 ECTS most likely will mean cutting the option of a 30 ECTS Project-Oriented Studies in an External Organization (POSEO) from the study plan, and this will definitely hurt employability and transition to employment
- Cutting POSEO from the study plan will also severely hurt the quality of theses, as many are done in collaboration with POSEO organizations and ultimately this will hurt the department's interaction with industry, also in terms of research
- MSN is concerned with the thesis semester being limited to 15 ECTS it will not be possible for students to achieve a sufficient level of depth in such a short thesis project
- MSN is concerned with the goals of starting the education earlier, as well as running the thesis block over summer. How will students be supervised and supported, when VIP staff and TAP staff is on vacation?
  - MSN is concerned with how to place re-exams. If students on the Master's start in August, when will they then take re-exams to get ready for the Master's?

CBM briefly showed the action plan for our programs. Specifically, he oriented about the SSD students that response that they spend 30 – 35 hours pr week, but to the staff they claim that they are stressed by project work and courses. It does not really make sense.

CBM has in this case had a meeting this morning with the coordinators of the program. One reply was that it is hard to get the students to attend the meetings.

It is also important to state that a coordinator have 2 semester group meetings and 1 evaluation meeting per semester.

We had a debate if there are any way to have reliable student responses next to the surveys as we know them today. Generally, students down prioritize the courses as when they go to job interviews, they only present project work.

CBM showed the department webpage where the employer panel meeting minutes from the May meetings can be found. This is a good chance to reflect on these meetings.

CBM: An employer panel mainly consists of two people from the industry. We invite them once a year, to inform them about the study, planning, employment etc. The meetings are important to the quality system at AAU.

The Study Board concludes that the "basispakke" is fine according to the needs of the students registered in our study plans. However, some of our students will need systems outside the "basispakke". E.g. Overleaf, Matlab, Unity, R, Refworks, VMware etc. etc.

Evaluation of study activities (ESA): One report made by the coordinator for every semester. How the semester ran, what was good and what was not good. Minutes from meetings, survey results and grade statistics.

Program evaluation: Quantitative information and qualitative information.

It can be difficult to get a big picture. And what do we do with all this stuff?

LGR: Would like to know if it has had any relevance. Would like to make it better for the next generation.

CBM: The surveys are challenged by very low response rates. The ESA is the responsibility of the coordinator.

We had a debate about what is visible in the daily life and what is put into the report. Relevance and how it is presented. Finally, how it is handled in other departments.

AMR: Would it be possible to have a report for the Program Evaluation like the ESA report?
