a) EVU separate course in biodiversity appendix 24-102 + appendix 24-113 sent by email

New course targeted at professionals wishing to improve their competences. (EVU = lifelong education)

NTE asked the study board members for ideas for supporting companies etc. that could be interested in this EVU course.

b) Suggestions for new members of the recruitment panel (Aftagerpanelet) Any suggestions for new members of our recruitment panel are welcome. NTE will send an email with an updated list of the members to the study board.

NTE: New members should preferably be top managers, in public administration or ministry and/or with a different background than from our own educations at AAU.

c) Allocated time for project exams

NTE: has asked the Prodean: how much time (standard) should be allocated for project exams? E.g., we are still waiting for a reply concerning this matter. For some exams, too much time is allocated – for others (e.g., Master thesis) too little.

d) Reports on three complaints

LHP: three student complaints filed to the legal office (Uddannelsesjura) One regarding an exam grade – we are still waiting for the outcome. The second regarding a specific course where it was claimed there was a difference between the course material and the questions asked at the exam. The request was denied.

The last complaint concerned a student who did not understand the grade from an exam and wanted to complain about the lack of information supplied by the examiners. The complaint was rejected due to filing the complaint after the deadline.

5. Discussion

a) Generative AI allowed as an aid in exams from E24

Information on DSUR decision appendix 24-103 LHP: All is by default approved for written exams and project work – if not, it has to be specified in the exam information/general exam regulations.

AAU report on generative AI in relation to exams appendix 24-104 LHP: good input and recommendations for students and teachers using AI. It was discussed in the study board about when AI is a good idea and when it is not, at exams and in classes.

b) Approval of exam schedules, Aalborg

6. Curricula

a) Revision of bachelor and diploma programs

The prodean ordered a revision of our curricula for the bachelor and diploma educations because the ministry of education has found them too similar. A process plan has been outlined by the faculty.

LHP: Three workshops have been held among the involved supervisors and lecturers. The resulting suggestions for changes are being described and discussed. The study board will discuss the suggested changes at the study board meeting in September.

The study board recommends that the education is approved for pre-approval, and the students with the SILA bachelor can enter our master's program.
