7. Evaluation of study activities, Fall 2022

CPH:

LID7

- Response rate: 10/16
- The semester appears to have run successfully, especially in terms of courses.
- Grade statistics look realistic.
- Some students air their frustrations concerning how to work in groups, functioning in groups, organize group work, write project report, etc. This is obviously a challenge for a study programme with such a broad student intake, and with so few students having an AAU Bachelor background. The Study Board is certain that the programme responsibles are doing everything they can to make students' transition into the AAU PBL model as smooth as possible.

OT: We seem to have PBL challenges in general. CBM is aware of some of the challenges, and we should do something about it.

Action:

LID9

- Response rate: 1/15 extremely disappointing
- The semester coordinator did not provide any observations or conclusions on how the semester went,maybe because student survey response rate was so low. But, there is the material from the semester
 group meetings The semester group meeting minutes do not follow the standard Study Board template
- The Study Board could be interested in some observations concerning the students' transition into thesis projects. How topics are chosen, how groups are formed (traditionally Lighting Design students tend to do thesis in 1-person groups), etc.

MED1C

- Response rate: 38/63
- The semester has suffered from some confusion and uncertainty due to problems with information flow to students, problems that have natural explanations presented in the evaluation report.
- Students should be commended for putting effort into commenting constructively on the survey.
- Self-reported weekly workload low, 60% work less than 40 hours per week.
- Generally, the semester seems to have run successfully despite communication challenges and coordinator appears to have clear plan for how to improve on those for next semester.

MED3C

- Response rate: 32/59
- Students should be highly commended for putting effort into commenting constructively on the survey.
- The semester is rated lower than usual, 48% is respondents rate the semester less good or not good.
- The coordinator's evaluation does not really offer any analysis on why students rate the semester so low, or on how that might be improved upon for next year. Concluding that it was a successful semester does not seem to be in line with survey results.
- The Mathematics for Multimedia Applications course gets very negative feedback.
- The comments in the survey contains so much extremely relevant information that the Study Board recommends that the coordinator and the course teachers go through it in preparation for the next version of the semester.
- The grade statistic are extremely unrealistic for the project unit (34 out of 56 got 12)
- In general, it seems that the students have had a hard time returning to physical study after two years of Covid-19 restrictions.

MED5C

MED7C

- Response rate: 10/27
- Grade distributions look very realistic and appropriate.
- The semester is generally rated quite high by the respondents.
- The evaluation report makes several references to uncertainty (amongst supervisors) regarding how to
 integrate the Machine Learning into projects, and how to weight it. The Study Board finds this very
 problematic a topic that must be addressed, perhaps through exchanging experiences with colleagues
 both in CPH and AAL. It is extremely important to have a successful and realistic study plan, but equally
 important to follow it.
- The evaluation report also mentions difficulties integrating some courses into the project.

CE: The students seem to have chosen the wrong elective courses which gave problems with the project work later in the semester. E.g., lack of Machine Learning skills.

CBM: It is a problem that it is not stated directly in the evaluation report.

Action:

CBM will arrange a meeting with the MED7 coordinators and teachers from both AAL and CPH to address the issue with the themes of the elective courses this semester.

MED9C

- Response rate: 8/41
- The Study Board is very pleased to see the extent and breadth of internship on the semester.
- Only 1 student chose DADIU, which is entirely different to AAL, where the balance is very shifted towards DADIU (14) as opposed to internships (8).

SMC7

- Response rate: 4/11
- Grade distributions appear realistic and responsible.
- Students are generally pleased with the semester, courses, and project.
- The integration/embedding of the PBL module into the semester appears to have been challenged.

SMC9

- Response rate: 2/12 abysmal
- The study board is concerned with the obvious lack of motivation to run the programme in view of it being shut down in its current form.
- The semester evaluation report is not carefully enough prepared to be of any real value.

SSD7

- Response rate: 13/25
- From the survey the semester appears to have been successful.
- Students should be commended for putting effort into constructively commenting on the survey.
- Coordinator's observations/recommendations for next semester give the Study Board confidence in steps being taken to continuously improve success of the semester.

SSD9

- Response rate: 7/36
- The semester appears to have been successful with students being in fulfilling internships.
- Coordinator's observations/recommendations for next semester give the Study Board confidence in steps being taken to continuously improve success of the semester.



AAL:

MED1A

- Response rate: 21/34 pretty good
- The semester is generally well evaluated by the students.
- The grade statistics look relevant and realistic.
- Courses are very highly rated.
- The Study Board is pleased to see how the in-semester workshops have contributed to the energy of the semester.
- The students report a high number of working hours compared to former students in this semester.

MED3A

- Response rate: 21/25 fantastic
- Students should be commended for putting effort into commenting constructively on the survey.
- Since this is the first time the semester is running according to a new study plan, difficulties could be expected. Integration between courses needs to be worked on.
- The Study Board has confidence in the observations and recommendations of the coordinators for the next version of the semester.

MED5A

- Response rate: 15/15 100% WOW.
- The semester is generally evaluated well by the students.
- The Rendering and Animation Technology course still struggles to achieve sufficient engagement from students and getting students to work with exercises/assignments on-site.
- The Study Board notices remarks concerning problematic group forming. The Study Board is highly
 aware of this topic and actually the whole University is debating pros and cons of different versions of
 group forming. The ambition level of the students is different, which often shows that the groups are
 made on beforehand.
- This is the last time this semester runs according to this study plan. Fall 2023 will be somewhat different and will pose its own challenges.

MED7A

- Response rate: 17/26 very good
- Grade statistic appear realistic ... perhaps a little high on the project grades.
- There is a somewhat high variance in how the semester is evaluated by students.
- The Machine Learning for Media Experiences course get quite negative feedback.
- The Real-Time Computer Graphics course has too much overlap with MED5 courses... this problem will go away when the new B.Sc. study plan is completely phased on, but for fall 2023 steps need to be taken to alleviate this problem.

MED9A

- Response rate: 8/24
- The Study Board is slightly concerned with how many students chose the DADIU option (14/22); ideally
 it would be a more realistic split with internships ... internship should perhaps be better promoted to
 students.
- DADIU, at least in AAL, also suffers from productions teams basically being composed entirely of AAL Medialogy students, so no exposure to other types of students and backgrounds.
